



DO YOU NEED A LITIGATION-READY NUIX DATA WAREHOUSE?



SIGNS YOUR ORGANIZATION COULD USE A NUIX DATA WAREHOUSE

IMPORTANT FIRST STEPS FOR IMPLEMENTING A NUIX DATA WAREHOUSE

- ☐ Involve executives in the decision-making process to ensure stakeholder buy-in.
- Choose one of Nuix's premier partners to help you implement your Nuix data warehouse—you may already work with this partner as your litigation services provider.
- Benchmark your current processes so you can quantify the improvements after you implement the Nuix data warehouse.
- Identify serial custodians within your organization and find where they keep their data.
- Gain an understanding of how much overlapping or serial custodian data is in scope.
- ☐ Configure your initial environment.
- Index all your serial custodian data into one case index for full searchability.
- Begin thinking about coding decisions such as privileged, intellectual property, trade secrets, private, and junk that you wish to track and append to the master record in your Nuix data warehouse and leverage as hints next time this record appears in a review.


- How many active matters do you have right now?
