

## NUIX LEGAL WEEK DRAWING OFFICIAL RULES

- 1. Eligibility: The Nuix Legal Week Drawing (the "Drawing") is open to Legal Week registrants ("Entrant"). Entrants must be at least 18 years old as of their date of entry in this Drawing in order to qualify.
